

# THE RURAL MUNICIPALITY OF EAST ST. PAUL

BY-LAW NO. 2022-16

## FEES AND CHARGES FOR THE YEAR 2023

**BEING** a By-Law of the Rural Municipality of East St. Paul to revise and consolidate a fee schedule for municipal services rendered under the authority of *The Municipal Act*, *The Planning Act*, and the by-laws of the Municipality.

**WHEREAS** in accordance with Section 232(2)(d) of *The Municipal Act*, a municipality may in a by-law establish fees or other charges for services, activities, or things provided or done by the Municipality;

**AND WHEREAS** the Council of the Rural Municipality of East St. Paul deems it advisable to consolidate into one by-law the fees and charges payable to the Municipality for various services provided by the Municipality;

**AND WHEREAS** the Rural Municipality of East St. Paul deems it necessary and expedient to keep current the schedule of fees for the services provided by the Rural Municipality of East St. Paul;

**NOW THEREFORE** the Council of the Rural Municipality of East St. Paul, in open Council assembled, enacts as follows:

1. **THAT** this by-law shall be known as the Fees and Charges By-law.
2. **THAT** the fees and charges payable for services provided by the Municipality shall be as set out in the following schedules:

Schedule "A"	Administrative
Schedule "B"	Fire Department
Schedule "C"	Public Works
Schedule "D"	Environmental Health
Schedule "E"	Transfer Station
Schedule "F"	Planning
Schedule "G"	Community Services
Schedule "H"	Utilities
Schedule "I"	Personnel
3. **THAT** Council may review this by-law when deemed necessary and all schedules within this by-law may be amended by resolution of Council.
4. **THAT** the fees and charges set out in the schedule attached to this by-law shall take precedence over similar fees referenced in any other by-law or resolution unless otherwise noted herein or as approved within legal mutual party agreements.

5. **THAT** any unpaid fees or charges owing to the Municipality that relate to property, including any penalties related thereto and any fines imposed on the taxpayer, may be added to the taxpayer's taxes and may be collected by the Municipality in the same manner as a tax may be collected or enforced under *The Municipal Act*.
6. **THAT** this by-law shall come into force and effect on January 1, 2023.
